Dr. Brian Q CannonDepartment Chair, History, Brigham Young University

Dr. Cannon graduated from BYU with a BA in American Studies in 1984. He completed an MA in History at Utah State University in 1986 and a PhD in History at the University of Wisconsin-Madison in 1992.

Since that time, he has been teaching at BYU. He teaches upper division courses in the American West in the Twentieth Century, Utah History, and U.S. History from 1890 to 1945.

Much of his research focuses upon agricultural settlement and rural community development and federal rural policy in the twentieth century. He has received fellowships or other awards from the Western History Association, the Agricultural History Society, the Charles Redd Center for Western Studies, the Ford Foundation, and the Aspen Institute for Humanistic Studies.

He and his wife, Anna Lea, are the parents of one daughter and four sons; and are the grandparents of five grandchildren.

Dear Cousins,

We will be voting on two proposed amendments to our Society bylaws at the banquet on May 3rd. Reserve your seat for the banquet now and we'll see you there! The proposed amendments can be found below.

Utah Society of Mayflower Descendants Proposed Amendments to the Bylaws

Article 1, Section 3 currently reads:

"All officers shall be elected for terms of one year and may be re-elected as often as the Society desires except the Governor, who shall not serve more than six years in succession."

Reason for the changes: To reflect the Society's current practice with regard to term lengths.

Article 7, Section 2, item F currently reads:

"A former member, desiring to be reinstated as a member of the Mayflower Society, may apply for such reinstatement by written application and by paying to the Treasurer of the Descendants of the Mayflower Society of Utah the annual membership fee that accrued during the year their membership expired, together with the membership fee for the year in which the application for reinstatement was requested and also the membership fee for the coming year. If the application for reinstatement is in the same year as the year of expiration, the total reinstatement fee would still be three times the existing annual membership fee. A person's check covering the above mentioned reinstatement fee may be considered as their written application for reinstatement.

Reason for the changes: To reflect the Society's current practice with regard to reinstatements.

Proposed Changes to Article 1, Section 3:

"All officers shall be elected for terms of three years and may be re-elected as often as the Society desires except the Governor, who shall serve a term of five years. The Governor shall not serve more than one term consecutively. The candidates duly elected shall assume office on the first of January succeeding the annual meeting at which they are elected."

Proposed Changes to Article 7, Section 2, item F:

"A former member, desiring to be reinstated as a member of the Mayflower Society, may apply for such reinstatement by written application and by paying to the Treasurer of the Descendants of the Mayflower Society of Utah the membership fee for the year in which the application for reinstatement was requested. An email request to the Treasurer or a person's check covering the abovementioned reinstatement fee may be considered as their written application for reinstatement. The reinstatement fee may also be paid by credit card."
